

**PEBBLECREEK LADIES 9-HOLE GOLF
ASSOCIATION (PCL9GA) NEW

Return your application, check made payable to PCL9GA and scorecards or a printout of the latest GHIN handicap index to the PCL9GA Treasurer's home. Meg Chrisman, 16543 W. Monte Vista Rd. Please keep copies for your records.

Membership is open to any homeowner or renter in good standing, in accordance with the PebbleCreek Homeowners Association rules/regulations. Active members of PCLGA are not eligible for concurrent PCL9GA membership. New members must provide one of the following: 1) Score Cards for 54 Holes of Golf on any Standard, rated golf Course. (This can be six (6) 9-hole scores OR three (3) 18-hole scores OR any combination of the two that adds up to the required 54 holes.) **OR** 2) An existing GHIN number from a previous golf club (a printout of your latest GHIN handicap index must be attached to this Application). Scorecard **Cards or GHIN Handicaps must be dated within the last 12 Months of the application.** Revisions will be daily so a player's Handicap Index will become active after their 3rd - 18-hole score is submitted.

A handicap index of no more than 27.0 for 9 holes or 54 for 18 holes is allowed for membership, plus familiarity with the Rules of Golf and proper golf etiquette and attire. Allow at least seven days for processing your application. You will be notified once processing is completed and will be scheduled for an orientation session. Before your paperwork is processed and you have attended a mandatory orientation session, you may play twice as the guest of a member or by arrangement with one of the New Member Co-Chairs listed below.

**FEES: \$89 New Members. This fee includes a one- time charge of \$6 for a name badge.
 \$83 Reactivating Members with a PCL9GA badge. Please add \$6 if you need a
new badge.**

Please note that name badges from other PebbleCreek organizations are not an acceptable substitute.

Memberships paid between October 1, 2024, and December 31, 2024, are valid through December 31, 2025.

Memberships paid between January 1, 2025, and September 30, 2025, are valid through December 31, 2025.

- Checks must be in U.S. funds drawn on a U.S. bank and made payable to "PCL9GA".
- If you were a previous PCL9GA member but have not played with the club in the last 12 months, you must submit new scorecards. Orientation is required if you have not played with the PCL9GA in the last 12 months
- To remain a PCL9GA member, each year the annual membership dues for the golf year, January 1st to December 31st, become due and payable on or before December 20 of the current year and are delinquent on December 21 of the current year.
